

Letter of Confirmation

Participant of Mannergute Mõõduvõtt

1. Participant confirmation

- 1.1. Mannergute Mõõduvõtt is not a motorsport event and not an activity with any form of competition. The aim of the test is to test the durability of automobiles from the last century and offer entertainment to the participants while carrying out the test.
- 1.2. Timekeeping is held only to give feedback to the organizer for ensuring the maximum safety of the event.
- 1.3. The participant has the right to choose the speed required to ensure safety for oneself, other participants and third parties. Any type of physical contact, competitive and dangerous maneuvers between two vehicles.

2. General confirmations

- 2.1. I have read the event instructions, its' extras and met with the event's location guidelines and will follow all its' regulations during the entire test.
- 2.2. I am aware, that signing the following contract owns legal power with responsibilities and consequences.
- 2.3. In case the guidelines of the given document, guide have not been followed or I do not wish to follow them for unknown reasons, I am obligated to quit the following event without getting a refund of the participation fee and other fees from the organizer.
- 2.4. I am aware, that driving a car is dangerous.
- 2.5. There is a risk with the durability test and staying on the track, that the driver will lose control over the car and there will be a crash with another driver on or near the road, crash with another participant, organizer or a third party person.
- 2.6. The consequences of these kinds of accidents may be extensive to me, the obligation to compensate the damage to other participants, car owner, organizer or third party people.
- 2.7. The accident may also cause permanent disability or death to the driver, other participants, organizers or a third party person.
- 2.8. I have been explained on the participants meeting, how to lessen the possibility of dangerous situations.
- 2.9. It is my obligation to take part of the participants meeting.
- 2.10. I understand that the instructions given by organizers do not exclude dangerous situations, accidents and damage.
- 2.11. I am responsible for my own action and the consequences of my actions during the entire event.
- 2.12. I am aware that the organizer can not guarantee that other participants will follow the rules and that their cars are in good technical condition.
- 2.13. I also understand that the raceroad is not closed for third party people and thus cannot avoid the damage that can come from the accidents with them.
- 2.14. I am obligated to use personal protection (minimally a helmet, overalls, safety belt), follow the guidelines of the test and the orders and notifications of the organizers.
- 2.15. I will do everything I can to avoid dangerous situations and accidents.
- 2.16. When I can't avoid the accident, I will try to lessen the damage that may come to other participants, third party people and organizers.
- 2.17. When there's damage done to me by myself then I will not submit claims to the organizers, people related to organizing, other people or third party people.
- 2.18. If someone causes damage to me by other participants or third party people, then it's my responsibility to deal with the compensation by the offender.
- 2.19. If there's a dispute about who's guilty or who should compensate then I will deal with it by negotiation or follow the guidelines given in the laws governing of the Estonian Republic.

- 2.20. I will definitely not ask for compensation from the organizers or people connected with organizing. I will also not involve them in the discussion about the compensations.
- 2.21. I am aware that usually insurance companies do not compensate the damages that have happened in closed territory, caused by other people, with an exception if there has been made a special agreement beforehand.

3. Driver's confirmation

- 3.1. I am the owner of the car that I'm driving or I'm using it with authorization.
- 3.2. In the last case I have gotten the authorization of the owner of the car to use it in the durability test.
- 3.3. I am obligated to prove that I have the authorization.
- 3.4. If I am not the owner of the car, then I am responsible for the damage that is done to the car, even if the damage is done by another person. I will obey the the regulations given by the insurance companies.
- 3.5. I make sure the vehicle I am driving is technically in a good condition and meets all the technical regulations.
- 3.6. I shall not drive under the influence of alcohol, drugs, medications or illness, nor when I am tired or in a condition that does not allow me to fully concentrate on driving safely.
- 3.7. I have received a 450€ costing timing device (transponder) from the organizer.
- 3.8. I must return the transponder right after the event and in case of damage or losing the transponder immediately compensate the price.
